WHEREAS, Appropriation Ordinance No. 2024-09, an Ordinance authorizing the appropriation of Supplemental Budget No. 06-2024 in the amount of **ONE MILLION THREE HUNDRED EIGHTY FOUR THOUSAND THREE HUNDRED FORTY SEVEN PESOS & 51/100 (P1,384,347.51)** derived from the excess of actual local revenue over estimated income for the grant of Economic Relief Assistance (ERA) to all municipal officials and employees the Municipal Government of Quezon, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

THE SANGGUNIAN PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-09 (Supplemental Budget No. 6 FY 2024) of the Municipality of Quezon, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following condition:

1. The grant of Economic Relief Assistance (ERA) to all municipal officials and employees in the amount of One Million Three Hundred Eighty Four Thousand Three Hundred Forty Seven Pesos & 51/100 (P1,384,347.51) shall be covered with appropriate guidelines and legal basis for its grant.

RESOLVED FURTHER, to require the Municipality of Quezon, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Quezon, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable JIMMY S. GAMAZON, JR.**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Quezon, Isabela through the **Honorable DARYL G. GASCON**, Municipal Vice-Mayor.
